SUBJECT: STAKEHOLDERS MEETING FOR PROPOSED SOLID WASTE FRANCHISE

The City of Los Angeles, Department of Public Works, Bureau of Sanitation (Bureau) is holding a series of stakeholders meetings to discuss waste hauling franchise options.

On November 16, 2010, a motion (Huizar/Koretz CF#10-1797) was introduced in City Council which directed the Bureau to explore whether including the commercial sector in the proposed multifamily franchise would help the City reach its Zero Waste, environmental and financial goals more expediently and efficiently. In response to this motion the Bureau is soliciting input from interested parties on this and related franchising issues.
